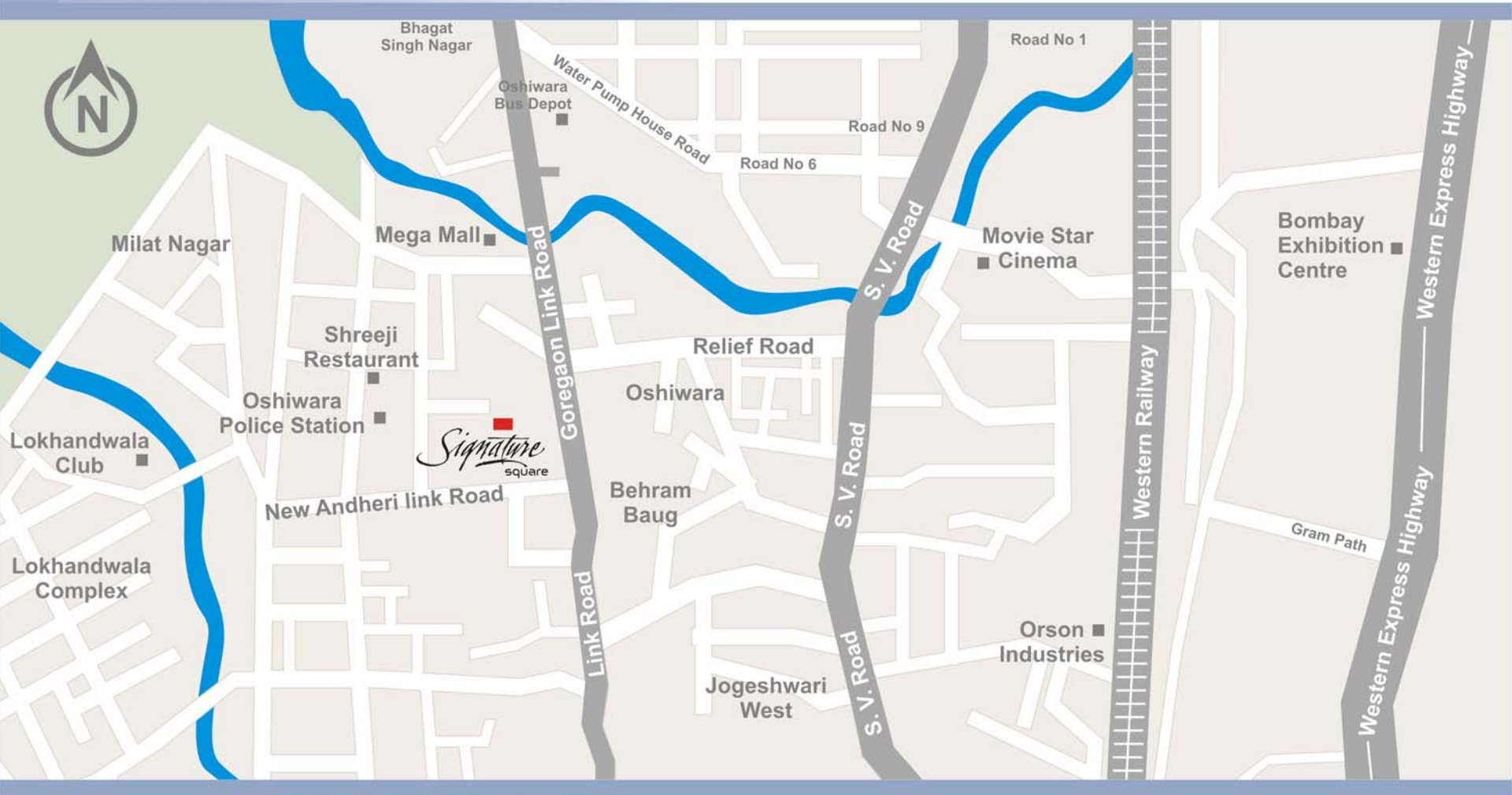

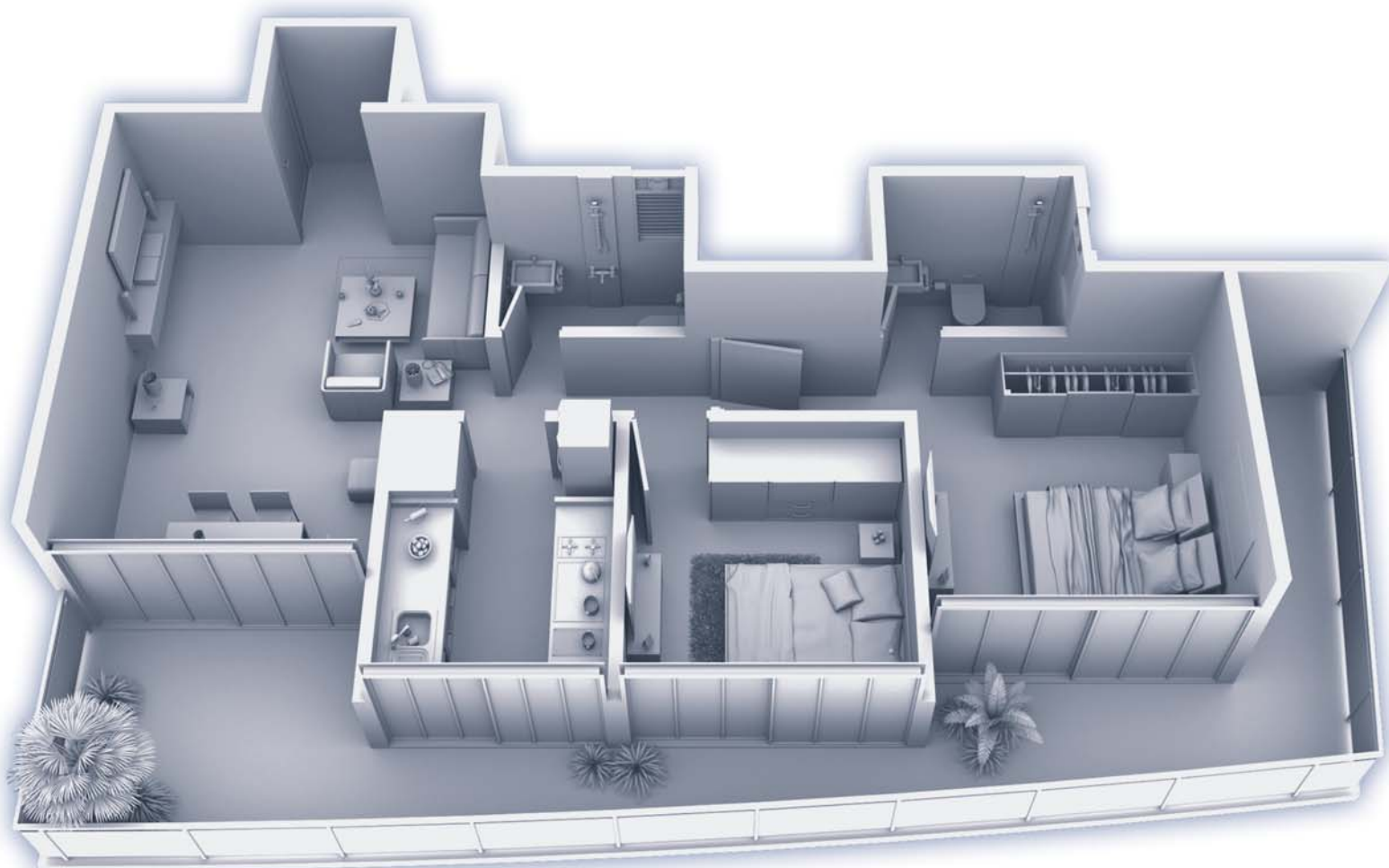


Other Essentials

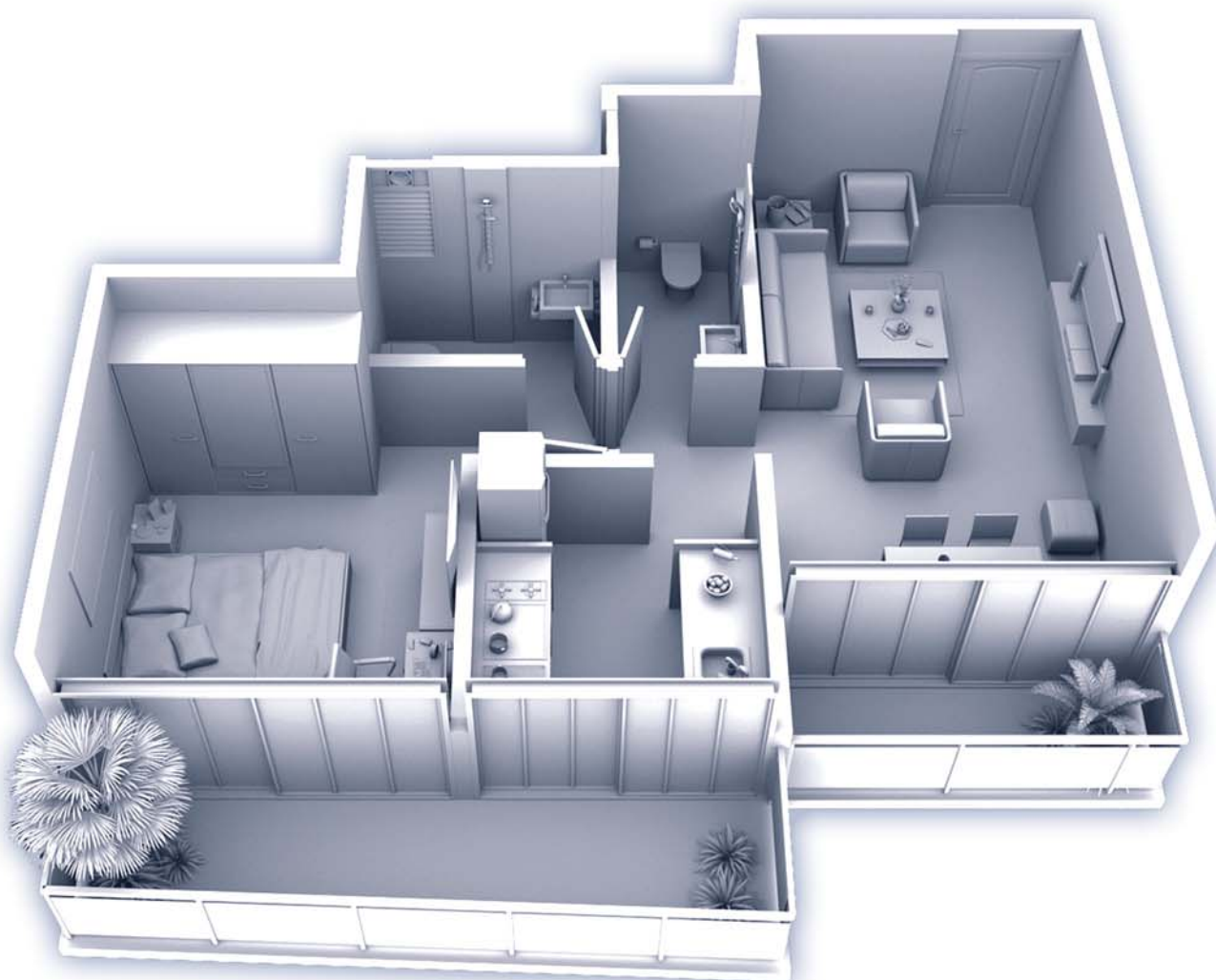

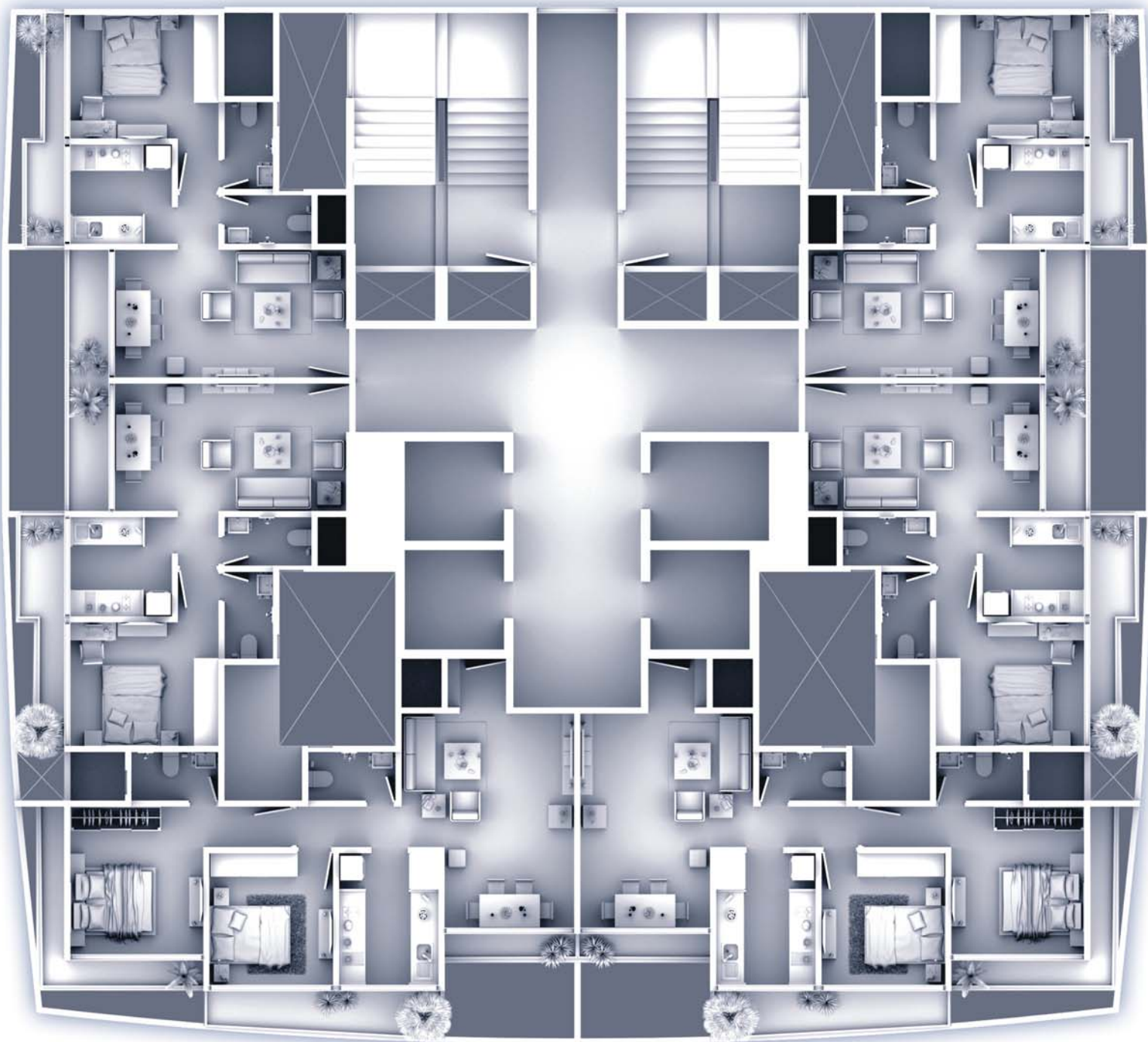

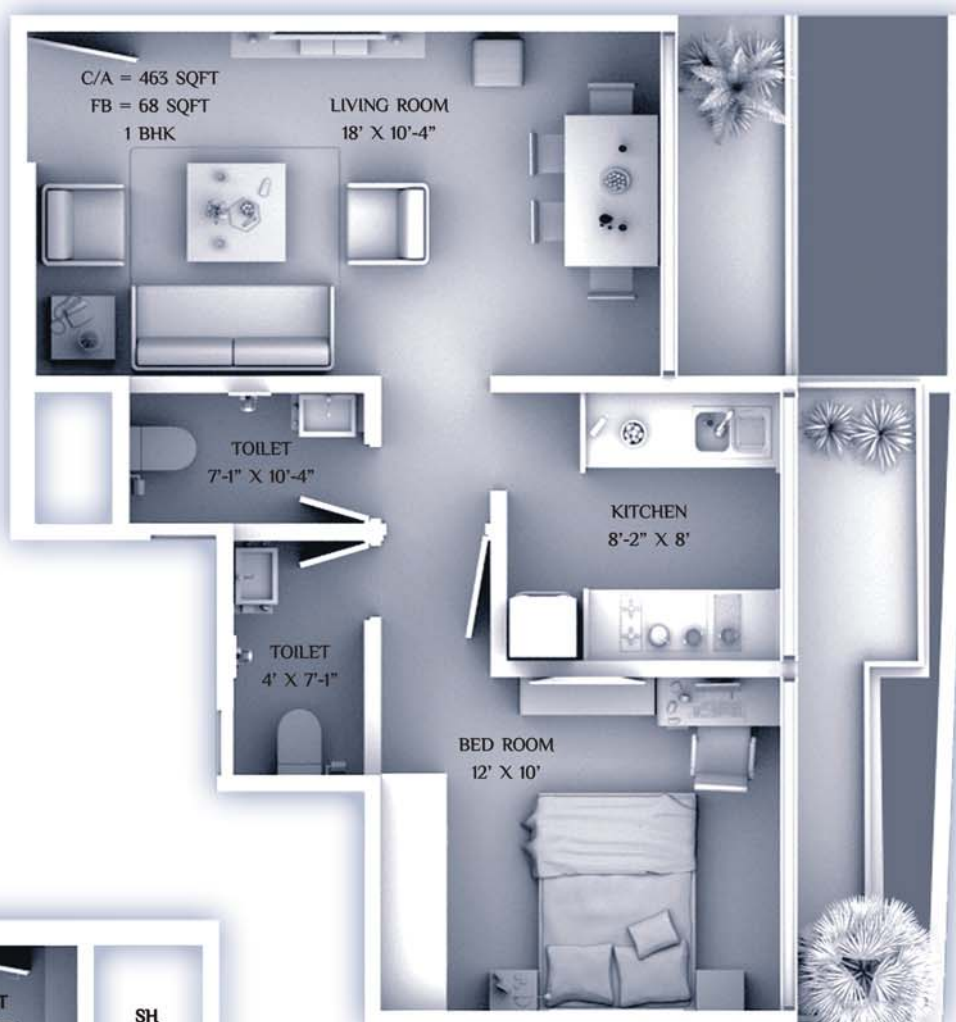
